#### **REGISTRATION FEE**

- NON-REFUNDABLE. NON-TRANSFERABLE FEES.
- Covers fixed costs such as teaching materials, textbooks, student workbooks, emergency supplies, student insurance, Field Day, Art Masters, and school yearbook.

#### **FAMILY DISCOUNTS**

Tuition Discounts are available to families who have two or more children enrolled in our school. Please contact Mrs. Lucas,
 Principal, to discuss the available options.

### **PAYMENT OPTIONS**

Tuition is an annual charge but may be paid in full or divided into equal monthly payments.

- Option A: Payment in Full with a 3% early payment discount if paying by cash or check due by June 30, 2023.
- Option B: 12-month payment plan, with the 1st payment due in June 2023 and continuing through May 2024.
- Option C: 10-month payment plan, 1st payment due in June 2023 and then September 2022 through May 2024.

### **TUITION PAYMENT**

- All tuition payments are made through **FACTS Management**. They will be automatically deducted from a designated checking account, savings account, debit card, or credit card.
- In addition to tuition payments, incidental charges including extended care and other fees are billed by the 10<sup>th</sup> of the next month using the FACTS Incidental Billing program regardless of whether a family has utilized FACTS as the means of tuition payment.
- Monthly tuition and incidental charges invoices and balance reminders will be sent to you via email.
- Monthly tuition payments are due by the 20th of the month.
- Pay by automatic debit through your checking or savings account or by credit card (MasterCard, Discover, and Visa). A
  convenience fee applies for credit card payments.
- A fee will be assessed for all late payments and any dishonored payments.
- If your child's start date is after September 15, 2023, the annual tuition will be pro-rated based on the number of days your child is enrolled in the school and will be divided into equal monthly payments.
- All final tuition payments (including children who start after the first day of school) must be paid by May 20, 2024, and any extended care and incidental charges incurred after that must be made by June 20, 2024.

## MID-YEAR ENROLLMENT

• For students enrolling any time after the first day of school, tuition will be pro-rated based on days remaining in the school year. There are no adjustments made to Registration Fees.

## WITHDRAWAL POLICY

To terminate enrollment, parents must notify the Principal in writing. In the event of student withdrawal after registration, all accounts must be paid up to and including the month in which the student is withdrawn. There are no refunds on previously paid tuition installments; this includes payments made from June through August. If the full year was paid in advance, only the equivalent remaining installments are refundable; and if the withdrawal is made before the first day of school, June through August's payments are non-refundable. There are no refunds of any kind after March 1st of the current school year. Report Cards and school records are not released until all accounts are current. A student's FACTS account will be terminated 30 days from the written notice of withdrawal.





Abiding Savior Lutheran School offers Variable Tuition to qualified families on a first-come, first-served basis. Awards are determined by each family's financial needs based on an application and supporting documents provided by the family. Students receiving Variable Tuition are expected to maintain commendable academic standing and attendance, behavior, effort, and citizenship. The students and their families will support the purpose, mission, and core values of Abiding Savior Lutheran School and are encouraged to be involved in the life of the school community.

Financial Aid applications are available **only** online through FACTS.

#### TO BE ELIGIBLE FOR FINANCIAL AID YOU MUST:

## 1. RETURNING STUDENTS & PRESCHOOL FAMILIES

Must have re-enrollment paperwork complete and the registration fee (non-refundable) paid before you can apply and receive any financial aid, and your tuition account must be in current/good standing.

## 2. **NEW STUDENTS**

The enrollment process must be completed, and the registration fee **(non-refundable)** must be paid before applying. Applicants who elect not to submit the registration fee with their aid application cannot be guaranteed a class seat and are subject to placement on a waiting list.

- 3. Submit only one Financial Aid application per household, regardless of whether you have more than one student or multiple students.
- 4. All supporting documentation must be uploaded to FACTS.
  - Copies of your 2022 Federal tax forms including all supporting tax schedules
  - Copies of your 2022 W-2 forms for both you and your spouse
  - Incomplete applications will be delayed in processing and will not be considered until all the information required by FACTS has been received.
- 5. There is a **\$40 application fee (non-refundable)** that will be requested by FACTS at the time of tuition assistance application submission.
- 6. Please **do not** return any information related to the financial aid process to Abiding Savior. Upon completion of your application, FACTS will contact you directly to confirm receipt. Should any information be missing or incomplete, you will be advised by FACTS.
- 7. Assistance is granted for a period of one school year. Under no conditions will assistance be granted beyond one year without a new application being filed.
- 8. Abiding Savior does not meet full financial aid needs and no student's tuition is 100% covered.
- 9. The deadline to apply to FACTS is **Friday, March 31, 2023**. Please note, there is one deadline for financial assistance. If you missed the deadline; you may still apply. However, late applications will only be processed if funds are available.
- 10. Financial aid awards and any/all other school discounts may not be combined.
- 11. At any time during the period of assistance if there is a change in the financial position of the recipient and the need for assistance ceases, it is expected that the school is notified so that the funding may be used for other applicants.
- 12. Abiding Savior does not discriminate based on race, color, nationality, or ethnic origin in administering financial assistance.

## NOTIFICATION:

Notice of acceptance or denial will be emailed to applicants by April 28, 2023.
